 WHILE IN TRANSIT to or from your facilities while under your supervision.
- Exclude deaths of ALL persons –  
 CONFINED in local jail facilities, whether located in or out of State;  
 UNDER YOUR JURISDICTION but housed in a State-operated correctional facility in another State or in a Federal facility.  
 DEATHS BY EXECUTION that were carried out in your State.
