# Jails in Indian Country, 2017-2018

total of 84 jails in Indian country held an estimated 2,870 inmates at midyear 2018, a 2% increase from the 2,820 inmates held in 84 facilities at midyear 2017 (figure 1). This marked an increase of nearly 1,100 inmates since 2000, when 1,775 inmates were held in 68 jails in Indian country. The average number of inmates per operating jail in Indian country rose from 26 inmates in 2000 to 34 in both 2017 and 2018 (table 1).

## Jails operating in Indian country increased from 68 facilities in 2000 to 84 in 2018

The Bureau of Justice Statistics (BJS) has conducted the Annual Survey of Jails in Indian Country (SJIC) since 1998, although the survey was not administered in 2005 and 2006. The number of operating jail facilities in Indian country increased from 68 in 2000 to 84 in 2018.

### HIGHLIGHTS

- A total of 84 jails in Indian country held an estimated 2,870 inmates at midyear 2018, up from 2,820 inmates in 2017 and from 1,775 inmates (held in 68 facilities) in 2000.
- Jails in Indian country were rated to hold an estimated maximum of 4,290 inmates at midyear 2018, up from 4,200 at midyear 2017.
- From midyear 2000 to midyear 2018, the overall rated capacity of jails in Indian country increased by 107%, while the midyear inmate population increased by 62%.
- Occupied bed space declined from 86% of rated capacity at midyear 2000 to 67% at midyear 2018.

- The number of inmates admitted to jails in Indian country in June 2018 (9,360) was more than three times the average daily population (2,790).
- For the 84 facilities operating in June 2018, the expected average length of stay for inmates at admission was about 9 days.
- Over half of all inmates (56%) at midyear 2018 were held for a violent offense (29%), public intoxication (16%), or a drug offense (10%).
- There were about two jail inmates for every jail-operations employee at midyear 2018, a ratio that has remained relatively stable since midyear 2010.

#### **Terms and Definitions**

*Average daily population (ADP)*—The sum of the number of inmates held each day in June, divided by 30.

*Expected average length of stay*—Calculated by dividing the ADP by the number of June admissions and multiplying by 30.

**Indian country**—The legal term used to describe reservations and other lands set aside for Indian use, such as Indian allotments, and lands held in trust for Indians or Indian tribes (18 U.S.C. § 1151).

*Jail-operations staff*—Correctional officers and other staff who spend more than 50% of their time supervising inmates.

*Midyear population*—The number of inmates held on the last weekday in June.

**Peak population**—The number of inmates held on the day in June on which the custody population of a facility was the largest.

*Percent of capacity occupied*—The jail population divided by the rated capacity.

**P.L. 280**—Under P.L. 83-280 (18 U.S.C. 1162), some states have jurisdiction to prosecute certain crimes committed by or against American Indians and Alaska Natives. State law enforcement and courts may arrest, investigate, prosecute, and punish offenders. With some exceptions, the law affects Indian country in Alaska, California, Minnesota, Nebraska, Oregon, and Wisconsin. Pursuant to the Tribal Law and Order Act of 2010, tribes are authorized to request that federal authorities re-assume concurrent federal jurisdiction.

**Rated capacity**—The maximum number of beds or inmates assigned by a rating official to a facility, excluding separate temporary holding-areas.

**Tribal Law and Order Act (TLOA)**—Signed into law in 2010, the act enhanced tribes' authority to prosecute and sentence criminals. It expanded law enforcement resources and tools, increasing staffing, training, and access to databases of shared criminal information. It authorized new guidelines for handling sexual assaults and domestic violence, and it encouraged development of more effective programs to prevent alcohol and drug abuse.

## Occupied bed space declined from 86% of rated capacity at midyear 2000 to 67% at midyear 2018


From midyear 2000 to midyear 2018, the rated capacity of jails in Indian country increased 107%, while the midyear inmate population increased 62%. So the rated capacity grew at 1.7 times the rate of the midyear inmate population. As a result, occupied bed space declined from 86% of rated capacity at midyear 2000 to 67% at midyear 2018. When measured relative to the average daily population (ADP), the percentage of rated capacity occupied in jails in Indian country was 65% in June 2018. This was down from 75% in June 2004, the first year ADP data were collected (not shown in tables). When compared to the most crowded day in June, occupied bed space declined from 118% in 2000 to 83% in 2018.

Beds in facilities rated to hold nine or fewer inmates were the least occupied, operating at 30% of rated capacity on an average day in June 2018, followed by facilities rated to hold 10 to 24 inmates (54%), 25 to 49 inmates (62%), and 50 or more inmates (68%) (figure 2). On their most crowded day in June 2018, facilities rated to hold nine or fewer inmates were operating at 63% of rated capacity, followed by facilities rated to hold 50 or more inmates (80%), 25 to 49 inmates (89%), and 10 to 24 inmates (96%).

Twenty-nine facilities (or 35% of all facilities) were operating above rated capacity on the most crowded day in June 2018 (table 2). Fourteen facilities were operating above rated capacity on the last weekday in June 2018 (17%), and 12 facilities were operating above rated capacity on an average day in June 2018 (14%).

## The 12 largest jails held half of all inmates in jails in Indian country

Of the inmates held in jails in Indian country at midyear 2018, an estimated 93% were held in the 59 facilities that were rated to hold 25 or more inmates (table 3). At midyear 2018, 66% of inmates were held in the 25 facilities that were rated to hold 50 or more inmates. The 25 facilities with a rated capacity of 24 or fewer inmates accounted for 30% of all facilities and held 7% of all inmates in jails in Indian country. Among all jails at midyear 2018, the population ranged from no inmates in five facilities to 295 inmates in the Nisqually Adult Corrections facility in Washington, which held 10% of the inmate population (not shown in tables). Overall, 12 facilities held half (50%) of the inmate population.

## Admissions to jails in Indian country decreased in 2018

In June 2018, the 84 jails in Indian country admitted an estimated 9,360 persons, down from 9,890 persons admitted to 84 facilities in June 2017 (table 4). Eighty-five percent of the total decline came from facilities rated to hold 50 or more inmates (450 of 530 admissions). In June 2018, admissions to facilities rated to hold 25 to 49 inmates (4,170) or 50 or more inmates (4,120) together accounted for 89% of admissions, similar to 2017. Facilities rated to hold 10 to 24 inmates accounted for nearly 11% (1,030) of all admissions to jails in Indian country in June 2017 and June 2018, and facilities rated to hold nine or fewer inmates accounted for less than 1% in both years.

The expected average length of stay (the time held in custody from admission to release) increased from 8 days to 9 days between 2017 and 2018, although this statistic varied by facility size. In 2018, inmates in facilities rated to hold less than 50 persons spent, on average, 6 days in jail from admission to release, while those in facilities rated to hold 50 or more spent almost 13 days on average.

#### Nearly 30% of inmates were held for a violent offense each year from midyear 2010 to midyear 2018

Since midyear 2000, the proportion of females held in jails in Indian country has increased. Although males consistently made up the majority of inmates, the percentage of female jail inmates increased from 20% of all inmates at midyear 2000 to a peak of 27% at midyear 2016 before declining to 25% at midyear 2018 (table 5). The proportion of juveniles held at midyear declined from 16% of all inmates in 2000 to less than 10% from 2013 through 2018 (not shown in tables).

The distribution of inmates by conviction status and offense type has also changed. After peaking in 2009 (at 69%), the percentage of inmates who were convicted steadily declined from midyear 2010 (59%) to midyear 2014 (51%).<sup>1</sup> It then increased to 55% at midyear 2015 and remained stable for a year before decreasing to 52% at midyear 2017 and then increasing to 55% at midyear 2018.

From midyear 2010 to midyear 2018, about 3 in 10 inmates in Indian country's jails were held for a violent offense. At midyear 2018, 15% of all inmates were being held for domestic violence, and 9% were being held for aggravated or simple assault. At midyear 2018, inmates held for other violent offenses (4%) or rape or sexual assault (1%) accounted for another 5% of the jail population.

Inmates held for DWI or DUI declined from 16% of the total inmate population at midyear 2000 to 5% at midyear 2018. The proportion of inmates held for a drug offense rose steadily, from 4% of all inmates at midyear 2010 to 10% at midyear 2018.

At midyear 2013, BJS enhanced the survey questionnaire's offense categories to include burglary, larceny-theft, and public intoxication, which allowed for more precise classification of previously unspecified offenses. About 1 in 5 inmates at midyear 2018 had been charged with public intoxication (16%), burglary (2%), or larceny-theft (1%).

#### The number of correctional staff in jails in Indian country increased from midyear 2010 to midyear 2018

Jails in Indian country employed an estimated 1,880 persons at midyear 2018 (table 6). From midyear 2010 to midyear 2018, jail-operations staff accounted for about

7 in 10 of the facilities' employees. Jail-operations staff consist of correctional officers, guards, and other staff who spend more than 50% of their time supervising inmates. The number of jail-operations staff increased 36% from midyear 2010 (1,010) to midyear 2018 (1,370). Overall, there were about two inmates to each jailoperations employee at midyear 2018, a ratio that has been relatively stable since midyear 2010. An estimated 510 employees (27% of all employees) in jails in Indian country held positions in administrative, educational, technical or professional, clerical, maintenance, food service, or other non-operational areas.

### Two deaths were reported in jails in Indian country during the 12-month period ending June 30, 2018

Jails in Indian country have reported 16 deaths in custody since midyear 2010 (not shown in tables). Two deaths were reported in the 12 months ending June 30, 2018. A total of 72 of the 84 facilities reported valid data on the number of deaths and the number of suicides for the 12 months ending June 30, 2018, and 69 facilities reported on the number of attempted suicides. Of these 69 facilities, a total of 62 facilities reported valid data on attempted suicides in 2017 as well. These 62 facilities represented 65% of the inmate population at midyear 2017 and 67% at midyear 2018. Among these facilities, 26 inmates attempted suicide in 2018, an increase from 12 attempted suicides in 2017.

### Methodology

The Annual Survey of Jails in Indian Country (SJIC) includes all Indian country correctional facilities operated by tribal authorities or the Bureau of Indian Affairs, U.S. Department of the Interior. The Bureau of Justice Statistics (BJS) has conducted the SJIC annually since 1998, excluding 2005 and 2006. Through a cooperative agreement with BJS, Westat, Inc. conducted the 2017 and 2018 SJIC, which is designed to cover all adult and juvenile jail facilities and detention centers in Indian country. The reference date for the 2017 and 2018 surveys is the last weekday in the month of June.

The surveys collected data about the number of inmates and jails' percentage of capacity occupied. Capacity occupied is based on the June 2017 and June 2018 average daily population (ADP), midyear population, and peak population in facilities in June 2017 and June 2018. (See appendix tables 1 and 5.) ADP is the sum of the number of inmates held each day in June, divided by 30. The midyear count is the number of inmates held on the last weekday in June, and the peak population is the number of inmates held on the day in June on which the custody population of a facility was the largest. BJS updates its existing roster of jails in Indian country annually. BJS obtains data from administrators of jails in Indian country by faxed or emailed questionnaires and through follow-up phone calls. The survey universe and response rates have changed over time. From 2004 to 2018, some facilities closed or merged, new facilities were constructed, and existing facilities became operational and newly eligible for the survey (**table 7**). Two facilities in 2011 (one adult and one juvenile) were treated as a single respondent in 2010, and two facilities in 2011 merged into one facility in 2012. A total of 76 facilities from the 84 eligible facilities reported 2017 data, and 75 of the 84 reported 2018 data.

When facilities did not respond to the survey or reported incomplete data, BJS used the most recent data available to impute the June midyear and peak populations, ADP, and admissions. BJS imputed data on inmate populations for seven non-responding facilities in 2004 (12% of all inmates held at midyear), four in 2007 (8%), two in 2013 (2%), five in 2014 (9%), seven in 2015 (15%), five in 2016 (9%), eight in 2017 (14%), and nine in 2018 (15%). All operating facilities responded to surveys from 2008 to 2012.<sup>2</sup>

For this report, Indian country includes reservations, pueblos, rancherias, and other appropriate areas (18 U.S.C. § 1151). Indian country is a statutory term that includes all lands within an Indian reservation, dependent Indian communities, and Indian trust allotments (18 U.S.C. § 1151). Courts interpret Section 1151 to include all lands held in trust for tribes or their members. (See *United States v. Roberts*, 185 F.3d 1125 (10th Cir. 1999).)

Prior to July 29, 2010, tribal authority to imprison American Indian or Alaska Native offenders had been limited to one year per offense by statute (25 U.S.C. § 1302), a \$5,000 fine, or both. On July 29, 2010, the Tribal Law and Order Act of 2010 was signed into law, expanding tribal court sentencing authority. As a result, offenders may serve potentially longer sentences (up to 3 years per offense and up to 9 years per multi-offense case) in Indian country correctional facilities (P.L. 111-211, H.R. 725, 124 Stat. 2258).

Tribal law enforcement agencies respond to both felony and misdemeanor crimes. For most of Indian country, the federal government provides felony law enforcement concerning crimes by or against American Indians and Alaska Natives. Certain areas of Indian country are under P.L. 83-280, as amended (commonly referred to as P.L. 280). P.L. 280 conferred jurisdiction over Indian country to certain states and suspended enforcement of the Major Crimes Act (18 U.S.C. § 1153) and the General Crimes Act (18 U.S.C. § 1152) in these areas. Indian tribes retain concurrent jurisdiction to enforce laws in Indian country where P.L. 280 applies.

#### Expected average length of stay for 2017 and 2018

The stock-flow-ratio method was used to measure the expected average length of stay for inmates held in June 2017 and June 2018.

#### 2017

Stock—ADP in June 2017 = 2,700

Flow—inmate admissions in June 2017 = 9,890

Stock-flow ratio in June 2017 = 0.273, which is calculated as 2,700 / 9,890

Expected length of stay (average number of days held in custody from admission to release) = 8.2 days, which is calculated as  $0.273 \times 30$  days.

#### 2018

Stock—ADP in June 2018 = 2,790

Flow—inmate admissions in June 2018 = 9,360

Stock-flow ratio in June 2018 = 0.298, which is calculated as 2,790 / 9,360

Expected length of stay (average number of days held in custody from admission to release) = 8.9 days, which is calculated as  $0.298 \times 30$  days.
