Law Enforcement Officers Assaulted North Dakota, 1990

"Assault on a law enforcement officer" is defined as an unlawful attack by a person upon a sworn officer which resulted in serious injury or in which a weapon was used which could have caused serious injury or death. Assaults not causing injury are included if they involve more than verbal abuse or minor resistance to arrest.

Law enforcement agencies throughout the state of North Dakota which participate in the Uniform Crime Reporting (UCR) program reported a total of 23 assaults upon law enforcement officers in 1990. This results in a law enforcement officer assault rate of 2.4 per 100 officers. There were no officers killed in the line of duty in North Dakota in 1990.

The UCR program collects information on the type of activity the law enforcement officer was engaged in when the assault occurred, the type of weapon used in the assault, the officer's type of assignment, whether the officer sustained injuries, and the time when the assault occurred. The information collected by the UCR program is summarized in this report.

It is uncertain whether there were more than the 23 reported assaults on law enforcement officers in 1990. Since many of the small police departments in the state do not report to the UCR program, it is reasonable to assume that some assaults may have gone unreported. It is also possible that some law enforcement officers in the agencies which do report to the UCR program may feel that the abusive treatment that they receive from time to time is "just part of the job" and did not report some of the incidents which could be classified as assaults.

Table I indicates that the primary weapons used in assaults of law enforcement officers were "personal weapons" -- hands, fists, and feet, etc. Personal weapons were used in 22, or 96 percent, of the 23 assaults reported. One assault with a knife was reported.

Thirty-nine percent, or 9, of the reported assaults occurred in responding to disturbance calls. Five assaults occurred during traffic pursuits and stops.

Eighty-seven percent of the officers assaulted sustained personal injury. (See Table II.) Of the 22 officers assaulted with personal weapons, 19 sustained personal injury.

Table III on page 3 presents the type of assignment and type of activity the law enforcement officers were engaged in when the assaults occurred. In 11 of the 23 assaults, officers were assigned to a one-person vehicle. Eight of these were alone and 3 were assisted.

Assaults on officers reported by county sheriff's departments and those reported by city police departments are presented in Table IV. Thirteen, or 57 percent, of the 23 assaults were reported by city police departments.

Forty-eight percent of all assaults reported occurred between the hours of 10 p.m. and 2 a.m. See Table V for a breakdown of reported assaults by time of assault and agency type.

Table VI presents the assaults by type of activity and time of assault.

Table VII lists officer assaults by UCR reporting agency and type of weapon used. Bismarck Police Department reported the most assaults with 5 and the Stutsman County Sheriff's Office reported 4 assaults in 1990.

Table VIII is a breakdown of assaults by agency and month in which the assault occurred. Five of the 23 assaults occurred in June and 4 occurred in February. The numbers involved are too small to determine whether any period during the year is more risky in terms of officer assaults.

Table IX represents the assault totals by type of activity for the period 1980-1990. Figure I presents the yearly assault totals graphically. The number of reported assaults on officers, at times, has varied substantially from one year to the next. The greatest fluctuation was an increase of approximately 59 percent from 1985 to 1986. The same number of assaults were reported in 1989 and 1990.
