## Four Percent More Prisoners in First Half of 1992

WASHINGTON, D.C. -- The nation's state and federal prison population grew by 31,449 inmates--just under 4 percent--during the first half of the year to reach a record 855,958 men and women as of June 30, the Bureau of Justice Statistics announced today. The Bureau, a component of the U.S. Department of Justice's Office of Justice Programs, said the six-month increase was well below the record 47,000 increase in prisoners recorded during the first half of 1989.

"This year's increase was the equivalent of about 1,209 more inmates every week, compared to 1,160 per week during the first half of 1991 and more than 1,800 additional prisoners per week during the first half of 1989," said Bureau Director Steven D. Dillingham.

"The 12-month growth from June 1991 to June 1992 was 6.4 percent--an increase of more than 51,000 inmates," he said. "Although this is the lowest rate of growth since 1984, the total increase in prisoners represents the third largest annual increase on record."

During the first half of the year, the federal prison population grew by 8.1 percent, compared to an increase of 3.4 percent among the 50 states and the District of Columbia.

Prisoners in the Western states increased by 3.2 percent during the first half of the year, compared to a 3.6 percent increase in the Northeast. Southern and Midwestern prisoner counts grew by 3.4 and 3.6 percent, respectively.

One state recorded double-digit half-year increases--West Virginia by 14.3 percent. Twelve states had prisoner growth of at least 10 percent for the 12 months ending June 30. Three states recorded declines during this one-year period.

During the first half of this year the number of female inmates in state and federal prisons grew 3.8 percent, the same increase among men. As of June 30, women prisoners accounted for 5.8 percent of all prisoners nationwide.

The number of prisoners per capita on June 30, 1991, also reached a record 319 sentenced offenders (inmates sentenced to a year or more in prison) held in state and federal prisons per 100,000 residents. There were 35 sentenced female offenders in prison for every 100,000 females in the population--for males the

incarceration rate was almost 18 times higher, 618 sentenced male prisoners for every 100,000 males.

Alaska. Prisons and jails form an integrated system. NPS data include both jail and prison populations.

Arizona. Population counts are based on custody data and exclude 86 male inmates housed in local jails due to crowding.

California. Population counts are based on custody data and include civil narcotic addict commitments, county diagnostic cases, Federal and other States' inmates, and salakeepers.

Colorado. Population counts for "inmates with over 1 year maximum sentence" include a small number of inmates with a maximum sentence of 1 year. Beginning June 30, 1991, Colorado is reporting jurisdiction population counts which are not strictly comparable to prisoner counts for prior reference dates.

Connecticut. Prisons and jails form an integrated system. NPS data include both jail and prison populations.

Delaware. In Delaware, populations of inmates given partially suspended sentences (part served in prison, part under probation) are included with the "inmates with over 1 year maximum sentence" only if the prison portion of the sentence exceeds 1 year. Prisons and jails form an integrated system. NPS data include both jail and prison populations.

District of Columbia. In the District of Columbia, populations of inmates given partially suspended sentences (part served in prison, part under probation) are included with the "inmates with over 1 year maximum sentence" only if the prison portion of the sentence exceeds 1 year. Prisons and jails form an integrated system. NPS data include both jail and prison populations.

Federal. Population counts for "inmates with a sentence of 1 year or less," include 1,615 males and 164 females whose sentence length is unknown. Population counts for "unsentenced inmates," include 1,681 males and 14 females who are under the jurisdiction of the U.S. Immigration and Naturalization Service.

Florida. Population counts are based on custody data.

Georgia. Population counts are based on custody data and exclude an undetermined number of inmates housed in local jails solely to ease crowding or awaiting pickup by State authorities.

Hawaii. Prisons and jails form an integrated system. NPS data include both jail and prison populations.

Illinois. Population counts are based on custody data. Counts of "inmates with over 1 year maximum sentence" include an undetermined number of inmates with a sentence of 1 year.

Indiana. Population counts are based on custody data and exclude 658 male and 70 female inmates held in local jails solely to ease crowding or awaiting pickup by State authorities.

Iowa. Population counts are based on custody data.

Maryland. While population totals are actual manual counts, the breakdowns for sentence length are estimates.

Prisoner counts may differ from those reported in previous publications and are subject to change as updated figures become available.

<sup>b</sup>The rate per 100,000 residents is based upon the number of prisoners with sentences greater than 1 year.

**Massachusetts.** Population counts are based on custody data and exclude 867 males housed in local jails due to crowding. Population counts could not be provided by sentence length. Counts of sentenced prisoners for earlier reporting periods may not be strictly comparable. Population totals are actual counts; however, the male/female breakdown is an estimate believed to be within 0.1% of the actual disaggregation. By law, offenders in Massachusetts may be sentenced to terms of up to 2 1/2 years in locally operated jails and correctional institutions. Such populations are excluded from the State count but are included in published population counts and rates for local jails and correctional institutions.

**Michigan.** Population counts are based on custody data and include inmates in the Community Residential Program.

**North Carolina.** In North Carolina, populations of inmates given partially suspended sentences (part served in prison, part under probation) are included with the "inmates with over 1 year maximum sentence" only if the prison portion of the sentence exceeds 1 year.

While population totals are actual counts, the breakdowns for sentence length are estimates believed to be accurate within 1% of the actual numbers.

**Ohio.** Population counts for inmates with maximum sentences greater than 1 year include an undetermined number of inmates with a sentence of 1 year or less.

**Oklahoma.** Population counts for inmates with maximum sentences greater than 1 year may include a small undetermined number of inmates with a sentence of 1 year.

Population counts exclude 369 male and 43 female inmates held in local jails solely to ease crowding.

**Oregon.** Population counts for inmates with maximum sentences greater than 1 year include an undetermined number of inmates with a sentence of 1 year or less.

**Rhode Island.** In Rhode Island, populations of inmates given partially suspended sentences (part served in prison, part under probation) are included with inmates with maximum sentences greater than 1 year only if the prison portion of the sentence exceeds 1 year.

Prisons and jails form an integrated system. NPS data include both jail and prison populations.

**Tennessee.** Population counts are as of June 26, 1992 and include 1,883 males and 74 females housed in local jails solely to ease crowding. Breakdowns of the inmate population by sex were estimated and the count of inmates with maximum sentences greater than 1 year includes a small number with sentences of 1 year.

**Texas.** Population counts are based on custody data.

**Vermont.** Population counts are as of June 5, 1992.

Prisons and jails form an integrated system. NPS data include both jail and prison populations.

**West Virginia.** Population counts exclude 325 male and 20 female inmates housed in local jails solely to ease crowding or awaiting pickup by State authorities.

**Wyoming.** Beginning June 30, 1992, Wyoming will be reporting jurisdiction population counts which may not be strictly comparable to prisoner counts for prior reference dates.
